**LESSON POLICIES:**

**Scheduling and Absences:**

- Students' lessons are reserved for a specific day and time on an ongoing, weekly basis for the duration of a semester. The semester blocks are as follows: **Aug 29–Jan 31 (Fall/Winter), Feb 1–Jun 30 (Winter/Spring), and Jul 1–Aug 29 (Summer).**
- A minimum notice of 2 lessons is required to discontinue.
- There is **no makeup** given for missed lessons.

**Credits**

- In case of an anticipated absence(s), lesson credits may be requested to be used towards the next billing cycle
- **Credits will be applied to a customer's account. They will NOT be refunded to a customer's card.**
- **Floating Credit** – to be used in the event of an excused absence. **Only 1 allowed per semester block.** Floating credits become available to new students after four lessons and must be requested in advance no later than 24 hours prior to the day of the lesson scheduled. Floating credits may not be used as part of the 2-lesson cancellation notification.
- **Teacher Absence Credit** – Is given to the student in the event of a teacher's absence.
- **Vacation Credit** – Only available to students enrolled in the Summer Semester. Must be requested in advance.

**Weather and On-Line Lessons:**

- Weather-related cancellations will be decided no later than 12 pm during the week, with Saturday lessons to be decided no later than 6:00 pm the previous evening whenever possible. \*Note: These cancellations will not automatically follow school closings.
- In-person lesson cancellations will be emailed and/or texted to students as well as posted on our Social Media pages.
- Should in-person lessons be cancelled, on-line lessons may be an option offered by the student's teacher. If on-line lessons are not an option, students will receive a credit to be applied toward the next billing cycle.

**Other:**

- Off-site student recitals are scheduled in winter and spring with exact dates to be determined by the studio.
- Creative Music Center is not responsible for unattended students and children.

**PAYMENT PROCEDURES:**

- Lesson payments are due in advance and will be charged to the designated credit card on file on the 21st of each month. If the 21st falls on a weekend or holiday, the lessons will be processed on the following business day.
- The number of lessons billed is based solely on the number of lessons that are allocated to the student in the next given month. (e.g., If a student's lesson day is Monday, they will be billed for the number of Mondays in each month)
- Lessons will be pro-rated for new students according to their start date.
- If lessons are stopped, remaining lesson credits will be held on the account for use in future lessons or by family members.
- Payment for sheet music, books and/or musical accessories must be made at time of receipt. Any item(s) on student's account that have not been paid will be charged to credit card on student's account.
- If a student's account becomes 7 days past due, a non-refundable late fee of \$20 will be assessed and student's lessons may be put on hold until his/her account is brought current.
- A \$30 fee will be charged to the student's account for any checks returned.
- Any student returning after a 3 month or longer absence will be charged another registration fee of \$30 (\$20 if second student in family is currently taking lessons).
- Failure to pay the full balance on student's account may result in default at which time student (parent/guardian if student is under 18 years old) will become responsible for Creative Music Center's costs incurred due to the collections process.
- Creative Music Center reserves the right to cancel lessons at any time.
